with interest thereon from this date at the rate of eight  
per cent. per annum to be  
computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further provides for an attorney's fee of fifty dollars

besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference  
being thereunto had, as will more fully appear.

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, and County and Township of Greenville, near Brandon Mills and Grace and Cemetery, and having the following lines, metes and bounds to-wit: Beginning at an iron pin in the center of an unnamed street, and running thence in an easterly direction about 138 feet to an iron pin on R. D. Smith's land; thence in a southerly direction along said Smith's line 50 feet to an iron pin on Robt. Smith's land; thence in a westerly direction along Robt. Smith's line 136 feet to an iron pin in the center of an unnamed street; thence along the center of said street in a northerly direction 50 feet to the beginning corner, and bounded by lands of R. D. + Robt. Smith land et al, this being the same lot of land conveyed to me by J. G. Gillespie by his deed bearing even date with these presents and not yet recorded.
