until paid in full; and interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and enforce this mortgage, said note and other proceedings for an attorney's fee of ten per cent
besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney, or by legal proceedings of any kind, all of which is secured under this mortgage; as in and by the said note, reference
being thereunto had, as will more fully appear.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,
bargain, sell and release unto the said Mrs R. V. Davis

all that certain parcel and lot of land situate lying
and being in the state and County aforesaid, in the
town of Greer on north side of Randall street, and design-
ated as lots nos. one and two on a plat of land prepared
by W. A. Christopher, Jan. 1919, and being the same lot of
land this day conveyed to me by Mrs R. V. Davis
and this note and the mortgage is given to secure
the purchase money debt for the foregoing described
