This 1st day of December 1918 at the rate of 8 per cent. per annum to be

computed and paid annually until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or

interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent. of the

amount due upon said note besides all costs and expenses of collection, to be added to the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mr. W. Gaines

All of that certain piece, parcel or tract of land, situate, lying and being in Austin Township, in the County of Greenville and State of South Carolina, and having the following metes and bounds, to wit: Beginning at a stone on Tom Leaque's line; thence N. 44° E. 10.46 to white Oak 320' w; thence S. 84° E. 13.73 to stone by sweet gum; thence N. 9° E. 14.60 to wild cherry; thence S. 84 1/2° E. 3.18 to stone; thence N. 24° E. 24.42 to stone on Anderson Bridge road, thence down the road in a south east direction 24.62 to iron pin, Wade & Drummond's corner; thence S. 43 1/2° W. 20.00 to stone; thence S. 48° W. 11.26 to stake in bottom; thence S. 65° W. 21.08 to the beginning containing Sixty (60) acres, more or less, and being the same tract of land this day conveyed to me by the said Mr. Gaines, and this mortgage is given to secure the balance of the purchase price of said land.
