1919 and Forty (\$40.00) Dollars each and every 90 days
hereafter until the full sum of Eleven hundred and Fifty Dollars is paid
with interest thereon from date at the rate of 7 per cent. per annum to be
computed and paid annually.

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten percent on amount
due.

besides all costs and expenses of collection, to be added to

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,
bargain, sell and release unto the said Mamie Montgomery Guy, her heirs and

assigns; All that certain piece, parcel or lot of land situated,
lying and being in the County and State aforesaid, in section
known as Mountain View, about 2½ miles Northwest of the City
of Greenville, and being known as lot No. 6 of Block "A" of the
property of the Mountain View Land Company, as shown on
plat recorded in the Office of M. C. Davis, Greenville County
in Plat Book "A" at pages 376 and 377, and having the
following metes and bounds to wit: Beginning at a pin on the
West side of Buncombe Road, joint corner with lot No 7, and
running thence in a Southwesterly direction 188 feet to a pin
on a ten foot alley, thence with said alley in a Southerly direction
53 feet to a pin, joint corner with lot No. 5; thence in an Easterly
direction along line of lot No. 5, 189 feet to a pin on Buncombe Road;
thence with said road 71.22 ft. 5.1 feet to the beginning corner
of all that other certain piece, parcel or lot of land situated,
lying and being in the County and State aforesaid, adjoining
the above described lot and being designated and known
as lot No 5 of Block "A" of above mentioned plat, and having the
following metes and bounds, to wit: Beginning at a pin on the
West side of the Buncombe Road, joint corner of lots Nos. 5 & 6 and
running thence with line of lot No 6, 189 feet to a pin on a ten foot
alley; thence with said alley in a Southeasternly direction 50
feet to a pin, joint corner with lot No. 4; thence with line
of lot No 4 in an Easterly direction 190 feet to a pin on the
Buncombe Road; thence with said Buncombe Road, N. 22° E.
50 feet to the beginning corner, and being the same lots
of land this day conveyed to me by the said Mamie Montgomery
Guy. This mortgage is given to secure a part
