Tindall and running thence S. 5-41 E. 250 feet to lot 71033 on said plat: thence N. 84-40 E. 84-40 feet to corner of lot No. 32: thence N. 2. 26 D. 2. 50, 4 feet to Crescent Avenue: thence along Crescent Avenue S. 84-40 E. 98-3 feet to beginning corner on Crescent Avenue, on the East by lot No. 32, on the South by lot No. 33 and on the West by lot No. 30 and being a portion of the lands conveyed to the Poine et al Realty Company by S.
