bargain, sell and release unto the said T. A. Fowler

All that piece, parcel or lot of land in Greenville Sp. Greenville County, State of South Carolina, in the City of Greenville, on the west side of Laurens Street, between Market Avenue and Washington Street, and having the following metes and bounds to wit: (Beginning at an iron pin on the west side of Laurens Street, being corner of lot once owned by Alice M. Gates; thence with said Laurens Street N. 16 E. twenty five feet to an iron pin; thence N. 74 W. one hundred feet to lot formerly owned by M. E. Dand; thence with line of said lot S. 16 W. twenty-five feet to line of lot once owned by Alice M. Gates; thence with line of said Gates Lot S. 74 E. one hundred feet to beginning corner, and being the same lot of land conveyed to E. S. Mallard by deed dated January 28th, 1919, and recorded in S.
