whosoever lawfully claiming or to claim the same, or any part thereof provided always Nevertheless, and it is the true intent and meaning of the parties to these Presents, that if *I* the said mortgagor shall and truly pay, or cause to be paid, unto the said Citizens Building and Loan Association of Greer, Greenville County, South Carolina, its certain Attorneys, successors or assigns, the said debt or sum of money aforesaid with interest thereon, if any shall be due, according to the true intent and meaning of said Bond and Condition thereunder written, then this deed of bargain and sale shall cease, determine and be utterly null and void; otherwise, it shall

remain in full force and virtue. And it is agreed by and between the said parties, that the said mortgagor *his* Heirs, Executors or Administrators shall and will insure the House and Buildings on said lot in the sum of not less than \$ *500.00*

and keep the same insured from loss or damage, by fire, and assign the Policy of Insurance of the said CITIZENS BUILDING AND LOAN ASSOCIATION of Greer, Greenville County, South Carolina, and that in case *he* shall at any time neglect or fail to do so, then the said CITIZENS BUILDING AND LOAN ASSOCIATION of Greer, Greenville County, South Carolina, may cause the same to be insured in its own name, and reimburse itself for the premium expenses of such insurance under this mortgage.

AND IT IS AGREED by and between the said parties, that in the case of default of payment under any of the conditions of the said Bond, for the space of three consecutive months, it shall be lawful for the said Citizens Building and Loan Association of Greenville County, South Carolina, to begin legal proceedings, or at its option after three weeks publication in one of the newspapers of the city of Greer, to sell the property hereby mortgaged at public auction, to apply the proceeds of sale to the extinguishment of the debt under this mortgage, and the payment of all costs and expenses, including Attorney's fees incurred by such sale, and the Bond intended to be secured thereby, returning the overplus, if any, to the said mortgagor, unless the same shall be ordered by a judgment or other mortgage creditor of the said mortgagor, and for the purpose of such sale, the said mortgagor hereby appoints and constitutes *his* resident of the said Citizens Building and Loan Association of Greer, Greenville County, South Carolina, and his successors in office, or assigns of corporations, or its successors *his* attorney or attorneys for *him* and in *his* name, to execute and deliver proper titles to the purchaser or purchasers for the premises sold.

And it is further Agreed, by and between the said parties, that the mortgagor shall hold and enjoy the said premises, until default of payment shall be made.
