Township, Greenville County, State of South Carolina, about 2-1/2 miles from the City of Greenville, on the

Anderson Road, containing 19.85 acres, more or less, adjoining lands of Mrs. Charles and others, being the same conveyed to me and W.T. Looper by S.G. Bagwell, January 3, 1908, deed recorded in Book WWW, page 180, the undivided one-half interest of W.T. Looper being conveyed to me by deed dated January 9, 1909 and recorded in Book ZZZ, page 521.
