 boundaries: Beginning at an iron pin 228 feet and 7
 inches from the North-west corner of North Main
 Street (as laid out on plat of Highland-Terrace) and
 Hillcrest Drive and running thence in a westerly
 direction with Hillcrest Drive, 75 feet to an iron
 pin, corner of lot number 5; thence S. 23.30 W. with
 lot number 5, 90 feet to an iron pin on an alley;
 thence running the alley S. 66.30 E. 75 feet to an iron pin
