About two and one half miles from Greenville Courthouse being known as lots nos 7 and 8 on plat by W. A. Hudson, dated January 20th, 1905 and recorded in R. M. C. Office for Greenville County in Volume N. N. N. page 485, and having the following lines:

Lot No 7: Beginning at an iron pin on Williams Street, thence N. 59 1/4 E. 210 feet to corner on Wright Street; thence with Wright Street N. 21. 20 W. 70 feet to corner of lot no. 8; thence with line of lot no 8 S. 59 1/4 W. 210 feet to corner of Williams Street; thence S. 21 W. 20 E. with Williams Street to the beginning corner.

Lot no. 8: Beginning at the corner of lot no. 7 on Williams Street, thence S. 59 1/4 E. 210 feet to Wright Street; thence with Wright Street N. 21. 20 W. 70 feet to corner of Hudson Street; thence with Hudson Street S. 59 1/4 W. 210 feet to corner of Williams Street and Hudson Street; thence with Williams Street S. 21. 20 E. 70 feet to beginning corner.
