in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said *B. M. Mc Gee*

all that piece, parcel, tract or lot of land situated in *Greenville* Township, Greenville County, State of South Carolina

about two miles west of the city of Greenville, near the Monaghan Mills, the town of New Hope, said lot is designated as lot no 3 on plat of New Hope, recorded in the R. M. C. Office in and for Greenville County, plat Book A at page 344, said lot has a frontage of fifty (50) feet on Hoyt Street, and a depth of One Hundred and Fifty (150) ft. being the same lot conveyed to me by Hardy Griffith by his deed 28th of August 1914 and recorded in the R. M. C. Office for Greenville County in Vol. 43 page 594.

Also all that certain piece, parcel and lot of land situate, lying and being in Greenville County, State aforesaid, about one mile west of the city of Greenville S. C. and near Monaghan Mills, on a subdivision of land known as New Hope on Hoyt St. and designated as Lot # 2 on a plat of said subdivision, which plat is recorded in the office of the Register of Deeds, Conveyance for Greenville County, in plat book A at page 307 and being one of the two lots conveyed to S.
