And we do hereby bind myself, my ourselves, our Successors Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said mortgagee, its Successors Heirs and Assigns, from and against us, our Successors Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming, or to claim, the same or any part thereof.

And I..... the said mortgagor, agree to insure the house and buildings on said land for not less than.....
