All of that lot of land situate in the City and County of Greenville, South Carolina, and described as follows; beginning at a stake on the West side of Westfield Street 100 feet from the corner of Westfield and Gibbs Streets, and runs thence N. 7-3/4 W. 253.6 feet; thence S. 19-1/4 W. 100 feet on line parallel with Westfield Street to an iron pin on Gibbs Street; thence with Gibbs Street S. 70-3/4 E. 253.6 feet to Westfield Street; thence with Westfield Street N. 19-1/4 E. 100 feet to the beginning, being the same land conveyed to me by James Gilfillin Oct. 3rd. 1916, and recorded in Vol. 41, page 173.
