according to the terms of the said note, and also in consideration of the further sum of Three Dollars to me, the said C. R. Bramlett,

in hand well and truly paid by the said The Bank of Commerce at and before sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said The Bank of Commerce, its successors and assigns

All that tract of land situate in Butler Township, in the County and State aforesaid, containing 145.45 acres, more or less - Beginning at a point in the center of Congaree road, corner of T.L. Green land; thence with said road S. 44-1/4 W. 2.20 to a point in the center of said road; thence S. 27.30 W. 1.13 to point in center of said road; thence N. 7-1/4 W. 7.66 to point; thence S. 82-1/2 W. 32.60 along line of R.F. Watson to point on branch; thence S. 12 E. 12.85 along branch to point on same; thence N. 73.12 E. 7.66; thence S. 27-1/2 E. 38.08 to Pine; thence N. 62-1/2 E. 15.85 along line of John Gordon to a point; thence N. 27-1/2 E. 18.25 along line of Julius Smith to iron pin; thence N. 47 W. 3.20 to iron pin; thence N. 27-1/2 E. 5.17 to iron pin; thence N. 45-1/2 W. 9.30 to iron pin; thence N. 27-1/2 E. 2.40 to stone; thence N. 45 W. 13.75 to beginning, said land conveyed to me by 2 deeds, recorded Volume 44 page 315 and volume 27, page 496.
