computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest of any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent

besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being
thereunto made, as will more fully appear.

bargain, sell and release unto the said J. H. Rush

lying, and being on the west side of Vannoy St. in
the City of Greenville, State and County aforesaid,
and having the following metes and bounds to-wit:
Beginning at an iron pin on the west side of Vannoy
St. joint corners of lots Nos. 18 and 20, and running
thence with line of lot #20 N. 71-50 W. 192 feet, 7 inches
to an iron pin, thence N. 20-19 E. 55 feet to an iron
pin, joint corners of lots 15, 16, 17, and 18, thence along
the line of lot No. 16 S. 71-50 E. 192 feet, 7 inches to
an iron pin on Vannoy St. thence S. 20-19 W. 55 feet
to the beginning corner.
