All that certain piece, parcel and lot of land situate, lying and being in Ward One of the City of Greenville, County and State aforesaid, in a sub-division of land known as "Oakland Heights" (property of W. C. Cleveland), Plat of which is recorded in the R. M. Co. office for Greenville County, in Plat Book "C", at page 147, and thereon designated as Lot No. 14, situate on the North side of Lois Street: Beginning at an iron pin sixty-five (65) feet East of the intersection of Lois Street and Oakland Avenue, and running thence with Lois Street S. 62-19 E. 65 feet to an iron pin, corner of Lot No. 15; thence with line of lot No. 15 N. 32-34 E. 123 10 feet to an iron pin, corner of Lot No. 8; thence with rear line of lot No. 8 N. 64-34 W. 65 feet to an iron pin, corner of lot No. 13; thence with line of lot No. 13 S. 34-50 W. 120.55 feet to the beginning corner, and being the same lot of land this day conveyed to me by A.
