side of the north fork of Saluda River on both sides
of the old Buncombe Road, and having the following

branch where it crosses the Buncombe Road run-
ning thence with the meandering of said branch
S. 39 E. 3 chains to the north fork of Saluda River
thence up the meanderings of said river to stake
corner of W. A. Hodges' land; thence N. 37 1/2 W. 36.40 chains
to stake 3 x 0; thence S. 30 W. 3.80 chains to B. G. (down)
stone 3 x 0; thence S. 69 W. 46 chains to W. C. 3 x 0; thence
S. 32 3/4 W. 67.40 chains to two dog-woods 3 x 0; thence
S. 65 1/4 W. two chains to chestnut 3 x 0 on knot; thence
S. 1 W. 12 chains to stake; thence S. 40 1/2 E. 13 chains
to stake at head of Burton Branch; thence with

Buncombe Road; thence with the Buncombe Road
