until paid in full; all interest not paid when due bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

ten percent besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collected in part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,  
be collected by an attorney, or by legal proceedings of any kind (all of which are secured under this mortgage); and by the said note, reference being  
thereunto had, as will more fully appear.

bargain, sell and release unto the said R. L. Ford and J. T. Smith

*all the lots of land situate in the State and County aforesaid near the town of Greer having the following, names and bounds: Beginning at the corner of lot # 2 on the National Highway and run thence with said Highway N. 87. 25 E. 71 feet to the corner of lot # 3; thence along the lines of this lot - S. 16. 20 W. 200 feet; thence S. 87. 25 W. 71 feet to the corner of lot # 1; thence along the lines of this lot - N. 16. 20 E. 200 feet to the beginning corner, being known as lot # 2.*

*Also all that other lot of land adjoining the above described lot and having the following meter and bounds: Beginning on the National Highway at the corner of lot # 2 and run thence with said Highway N. 87. 25 E. 71 feet to the corner of lot # 4; thence along the line of lot # 4, S. 16. 20 W. 200 feet; thence S. 87. 25 W. 71 feet to the corner of lot # 2; thence along the line of this lot - N. 16. 20 E. 200 feet to the beginning corner, being known as lot # 3.*
