side of Lois St. and being more particularly described as follows: Beginning at a stake on  
the north side of Lois Street (originally) Mrs. Cookseys corner, and running thence in an  
easterly direction along said Street 57 feet to an iron pin originally F.M. Langley corner;  
thence with Langleys line in a northerly direction 108 feet to a fence on line of the  
Farrell lot; thence with line of the Farrell and Earle lots in a westerly direction  
55 feet to Mrs. Cookseys line; thence with her line in a southerly direction 108 feet to the
