WHEREAS, I, the said L. Reid Jackson

in the full and just sum of Twenty seven hundred dollars

with interest thereon from November 5th 1919 at the rate of 5 per cent. per annum to be  
computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

10 per cent besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,  
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being  
thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,  
bargain, sell and release unto the said Mrs S. O. Jackson

All that piece, parcel or lot of land located on the South  
side of West Earle St. between Hilton and Robinson  
Streets in Ward One of the City of Greenville in Greenville  
County, State of South Carolina, and known as Lot "N"  
Map of lands of Mountain City and Improvement  
Company having the following meters and bounds  
to wit: Beginning at a stake 214 1/2 feet west of Wil-  
ton Street on West Earle Street; thence N 84 1/2 W. 54 1/3 feet  
to a stake corner lot M; thence with line of last  
mentioned lot S. 5 1/2 W. 200 feet to stake; thence S. 84 1/2 E.  
54 1/3 feet to a stake; thence N 5 1/2 E. 200 feet to beginning  
corner, this being one of the two lots conveyed to Hattie  
D. Smith by Mountain City Land and Improvement  
Company by deed dated Jan. 7th. 1895 and convey-  
ed to Cora E. Blackwood by Hattie D. Smith by  
deed dated October 22, 1918, and conveyed to me by  
Cora E. Blackwood by deed dated November 5th. 1919.

1918 and assumed by me
