WHEREAS, I, Henry Foister, the said Henry Foister

interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of Ten per cent

besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being
thereunto had, as will more fully appear.

bargain, sell and release unto the said Henry P. McGee

His heirs and assigns all that piece par-
cel or lot of land situate lying and being in
the County of Greenville, in the State aforesaid
and near the city of Greenville, and designated
as lot no. (5-9) of Block one on a plat dated 14th
of May 1914 by A.S. Bedell surveyor, and being
a part of tract containing twenty acres, con-
veyed to A.H. New, by deed dated 29th June
1905 and recorded in R.M.C. Office Greenville
County Vol. 000, page 314, and conveyed to
G.H. Lunderman, by said A.H. New, and recorded
in Vol. 36, page 28, Greenville County South Car-
olina and conveyed to Henry P. McGee
Dec. 29th 1919 deed settled in Full by G.H. Lunderman
