Dollars, to be paid in five equal annual installments with the
right to anticipate payment

with interest thereon from date at the rate of Seven per cent. per annum to be
computed and paid Semi-annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of

Ten (10%) per cent besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being

bargain, sell and release unto the said J. W. Norwood

All that certain piece, parcel and lot of land situate
lying and being in Greenville County, State of South Carolina
and in the Fourth Ward of the City of Greenville, on the north
side of Mc Bee Avenue, and having the following, metes, bounds,
courses and distances to-wit: Beginning at a point on
Mc Bee Avenue 20 feet from A. E. Boyd's corner on said Ave-
nue and running thence N 16 1/4 E. 125 feet to stake; thence
N. 73 3/4 W. 25 feet to a stake; thence S. 16 1/4 W. 125 feet to the
said Mc Bee Avenue; thence along said Avenue S. 73 3/4 E.
25 feet to the beginning corner and being a portion of a
certain lot of land this day conveyed to me by the said
J. W. Norwood, and this obligation is made to secure a bal-
