We Robert Barksdale, & Ella Barksdale of the City and County of Greenville in said State SEND GREETING:

WHEREAS, we, the said Robert Barksdale & Ella Barksdale in and by our certain promissory note S. in writing, of even date with these presents, are well and truly indebted to

in the full and just sum of Six hundred dollars (\$600.00) Dollars, to be paid in twelve equal installments of fifty dollars each as set forth in notes

with interest thereon from the day of date at the rate of 7 per cent. per annum to be computed and paid

until paid in full; and interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of 10 per cent in case of suit or collection through an attorney besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That we the said Robert Barksdale & Ella Barksdale in consideration of the said said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

C. H. Gates according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to us the said Robert Barksdale and Ella Barksdale in hand well and truly paid by the said C. H. Gates

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said C. H. Gates.

All that certain piece parcel, or lot of land situate in the State and County aforesaid, about one and one-half miles west of Greenville Court House and having the following metes and bounds to wit; Beginning at a stake on the west side of a new road leading from the Cedar Lane road to the Buncombe road, which stake is 180 feet from said Cedar Lane Road and running thence along said new road N. 31 1/2 E. fifty feet to a stake or corner, of the property of C. H. Gates, thence along line of said property of said C. H. Gates, N. 40 1/4 E. 164 feet to a stake or corner, thence S. 31 1/2 W. fifty feet to a stake or corner, thence S. 40 1/4 E. 164 feet to beginning corner.
