all that piece, parcel, tract or lot of land situated in Greenville at 9:45  
Township, Greenville County, State of South Carolina.

Near the Monaghan Mills, known as lot no. 7, and  
part of lot no. 8 (now plat of Morgan Hill recorded  
in Plat Book A, page 70, and having the following  
metes and bounds: Beginning at a stake on the  
north side of O'Neal Street 238 feet east of Braudon  
Road, and running thence N. 7 1/4 W. 262 feet to stake  
on line of lot no. 2; thence line of lots nos. 2 & 9,
