 County on March 18 1911 in Plat Book "A" page 461 and having
 the following metes and bounds to-wit:

Lot no. 129: Beginning at a stake on the west side of Mc D. Ave.
 350 feet southward from Summit Street and running thence N. 89 $\frac{1}{2}$ W.
 40 $\frac{1}{2}$ feet with line of lot no. 128 to a stake on Hunt Street, thence along
 Hunt St. S. 10 W. a little more than 50 feet to a stake on the
 corner of lot no. 130 hereinafter described, thence along line of last mentioned
 lot S. 89 $\frac{1}{2}$ E. 149 feet to a stake on Mc D. Avenue, thence along
 said Ave. N. 12 E. 50 feet to the beginning corner

Lot no. 130 - Beginning at a stake on the west side of Mc D. Ave.
 250 feet northward from the northwest corner of Mc D. Ave. and
 Omall Street on joint corners of lots nos. 130 and 131; thence along
 Mc D. Ave. N. 12 E. 50 feet to a stake on corner of lot no. 129 thence
 along line of last mentioned lot S. 89 $\frac{1}{2}$ W. 149 feet to a stake on
 Hunt Street, thence along Hunt Street S. 10 W. to a stake on the corner
 of lot no. 131; thence along line of last mentioned lot S. 89 $\frac{1}{2}$ E. 157 $\frac{1}{2}$
