his heirs and assigns, all that certain lot, piece parcel and lot of land situate, lying and being in the State of South Carolina, and County of Greenville, in the Sixth ward of the City of Greenville known and designated as lot numbered (3) on plat made by W. B. Hesse, bearing date March 13th 1920, and having, according to said Plat, the following metes and bounds, to-wit: Beginning at an iron pin on the East side of Augusta Street, on the South West of corner of lot no. 3, which pin is 163.6 feet from the South side of McKay Street and 201.8 feet from the North side of Lindal Avenue, and running thence N. 89° 08' two hundred feet along the line of lot no. two (2) to an iron pin on line of the Hoppins lot, formerly referred to as lot no. 5 in F. P. Johnston's survey of the Lenhardt property, thence along line of said mentioned lot S. 30° E. seventy three and one-half ft. to an iron pin on line of the Valley lot thence along said mentioned line S. 59° W. one hundred & seventy-seven ft. to an iron pin on Augusta St. thence along said St. N. 25° 15' W. eighty-one & eight-tenths ft. to the beginning corner. This being the first & only mortgage on the aforesaid lot of land also all that other piece, parcel & lot of land, lying, being & situate in the State & Co. aforesaid in and in the City of Greenville, on which lot there are two buildings, one being occupied by the mortgagee & the other in the rear of said lot being occupied by negroes. Do joining lots with W. B. Anthony, James Rutledge & others & fronts on Westfield St. and runs back to a public alley, & has the following metes and bounds to-wit: Beginning at a stake on Westfield St. on the corner & running thence with new line 67 1/2 W. 280 feet to a stake on South St. alley, thence with said alley N. 18 1/2 W. 54 feet to a stake thence S. 67 1/2 E. 280 ft. to a stake on Westfield St. thence with said St. 18 1/2 W. 54 ft. to the beginning corner. It is understood that that this is the fourth mortgage, in priority on said lot mentioned premises, the first mortgage on the said premises being held by Mrs. S. M. Jones for eleven hundred (\$1100.00) dollars, the second is also held by Mrs. S. M. Jones & is for \$500.00 dollars, the third mortgage held by Mrs. W. H. Earle and is for six thousand (\$6000.00) dollars.
