All that certain lot or parcel of land situate, lying and being in Greenville Township, County and State aforesaid near the City of Greenville on the South side of the Augusta Road being known and designated as lot #3 on a plat of the property of Mary B. Lewis now owned by me, Sarah C. Westervelt, Melville Westervelt and Nade W. Calmer. Said lot has the following metes and bounds: Beginning at a point in concrete step on the Augusta Road joint corner of lots 2 and 3; thence with the joint line of said lots S. 25° 44' W. 414.6 feet to an iron pin in line of lot #5; thence with line of lot #5 N. 46.30 W. 82 feet to another pin joint corner of lots 3 and 4; thence with joint line of lots 3 and 4 N. 21.41 E. 425.4 feet to an iron pin on South side of Augusta Road; thence with said Augusta Road S. 46.30 E. 113 feet to the point of beginning.
