I, W. N. Cruikshank SEND GREETING:

WHEREAS, I, the said W. N. Cruikshank
in and by a certain promissory note in writing, of
even date with these presents, and well and truly indebted to

in the full and just sum of Four Hundred + 22/100
Dollars, to be paid one year from date

with interest thereon from the date of at the rate of 8% per cent. per annum to be
computed and paid monthly

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue
thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent

besides all costs and expenses of collection, to be added to
the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being
thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I the said W. N. Cruikshank
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said

W. N. Cruikshank
in hand well and truly paid by the said Sam R. Zimmerman

and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,
bargain, sell and release unto the said Sam R. Zimmerman his heirs and assigns

all that certain piece parcel or lot of land, situate, lying
and being in the City and County of Greenville, State
of South Carolina, on Queen Street, and having the following
meters and bounds to-wit: Beginning at corner of
lot of Davis on Queen Street, and running thence
N. 54-30 W. 141-5 feet along the line of said
Davis lot to iron pin on line of Scott Estate,
thence N. 36-30 E. 92-3 feet along line of Scott
Estate to iron pin; at corner of lot formerly
owned by Robert M^r Tinney; thence S. 54-30 E.
141-3 feet along line of M^r Tinney lot to corner
on Queen Street; thence S. 36-30 W. 92-3 feet
along said Queen Street to the beginning corner
according to a survey made by Will D. Neves,
Engr. December 18 1913, and being the same lot
