computed and paid.

until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue
thereon and foreclose this mortgage, said note further providing for an attorney's fee to

ten per cent besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, in the same manner as if said debt, or any part thereof,
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being
thereunto had, as will more fully appear.

Greenville and having the following meters & bounds.
Beginning at a stone on said road and running

15. 70 chains to a stake, thence near fork of branch
on Mrs Adelaide Stuffs line thence N. 62 1/2 E. 32. 00
chains to a stone in said fork shoals road thence a-
long said road to the beginning corner, and containing
50 1/2 acres more or less, Being the same land convey-
