in the full and just sum of Seven hundred seventy-five (\$775.00) dollars  
Dollars, to be paid \$100.00 July 10, 1921; \$100.00 January 10, 1922;  
\$100.00 July 10, 1922; \$100.00 January 10, 1923;  
\$100.00 July 10, 1923; \$100.00 January 10, 1924;  
\$100.00 July 10, 1924 and  
\$75.00 Jan. 1925.

with interest thereon from date at the rate of eight per cent. per annum to be  
computed and paid semi-annually  
until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue  
thereon and foreclose this mortgage, said note further providing for an attorney's fee of

Ten per cent besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,  
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,  
bargain, sell and release unto the said W. H. Mc Gaha,

Accepted  
two certain lots or parcels of land designated  
as Lots no. 7 and no. 14 of the sub-division of the parcel  
of land heretofore conveyed to the mortgagee by J. J. Mc Swain  
Beginning at joint corner of myself, Judson Mills and  
R. N. Bishop and running thence along line of Judson  
Mills property 60 feet, more or less, to stake; thence  
239 feet more or less, to corner on Cleveland property  
thence along the Cleveland line 60 feet to joint corner  
of Cleveland, Bishop and myself, and thence along the  
original line of the lot heretofore conveyed to the mort-  
gagee by J. J. Mc Swain, being the boundary line between  
the mortgagee and R. N. Bishop, 239 feet, more or less,
