Jordan* in hand well and truly paid by the said *Chicora Bank, Pelzer S.C.* at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release, unto the said *Chicora Bank, Pelzer S.C.*

all that certain piece, parcel or tract of land situated in Oaklawm Township, County and State aforesaid, about two miles south of Pelzer on the east side of the Holland's Fork road, containing forty-two acres more or less, being lot no. 10 of subdivision of the estate of Mrs. Narcissus W. Anderson, deceased, as shown by plat made by C. Hawes, Jr. Nov. 28, 1913, and recorded in the Office of R. M. C. Greenville County, S. C. in Plat Book C, Pages # 74 to # 77 inclusive. This being a portion of the same land deeded by Albert M. Anderson, executor for Narcissus W. Anderson, as per title recorded July 24, 1913, in Plat Book 54, page 89. Reference to the above mentioned plat in the last mentioned deed is made for metes & bounds of this property.
