AND IT IS AGREED, By and between the said parties, that *W. B. Rogers* to hold and enjoy the said premises until default of payment shall be made.

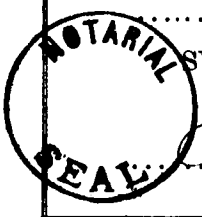
