assigns, all that lot of land situate in Ward six of the city of Greenville, County and state aforesaid on the North side of Choice Avenue, Beginning at a stake at G. W. Ward's (formerly Bonars) corner on Bridge Avenue and runs thence in a westerly direction 88 feet to Carrie Hunter line, thence in a northerly direction with said Hunter line to Turner University line, thence with said line in an easterly direction to Needy River, thence down with said River to the old Choice line, thence with said line in a southerly course to the Ward corner, thence with said line in a westerly course to said corner or said lot, thence in a southerly direction with said Ward line to the beginning corner.
