Fifteen hundred and one (\$1500.00) DOLLARS, to be paid in semi-annual installments of not less than one hundred dollars each, yearly thereafter, from the date and at regular intervals of one year thereafter, without interest.

with interest thereon from the day of Oct 15, 1921 at the rate of per cent per annum, to be computed and paid until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose his mortgage; said note further providing for an attorney's fee of ten per cent of indebtedness then owing

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Hovey Smith and his heirs and assigns forever, all that tract of land, situate, lying and being in the State of South Carolina and County of Greenville in the town of Simpsonville, containing one-fourth of an acre, more or less, and having the following borders and boundaries to wit: Beginning at a stake $\frac{3}{4}$ on the corner of Curtis and Maple Streets, and running thence along Maple Street $24\frac{1}{4}^{\circ}$ one hundred and five (105) feet to a stake $\frac{3}{4}$ on Maple Street, thence $8.64^{\circ} W.$ one hundred and five (105) feet to a stake $\frac{3}{4}$; thence $8.64^{\circ} E.$ one hundred and five (105) feet to a stake $\frac{3}{4}$ on Curtis Street; thence along said Curtis Street $11.64^{\circ} E.$ one hundred and five (105) feet to the beginning corner; this being the same land this day conveyed to me, the said Walter A. Smith by the said Hovey Smith, this being a first mortgage upon said property, given to secure the payment of the balance of the purchase money therefor.
