Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said

the following described real Estate: All that certain lot of
land situate, lying and being near the corporate limits of
the City of Greenville County and State aforesaid, on the
South side of Laurens Road and being known and designated
as lot no. 1 of Glenn Grace Park as shown by a
sub-division and plat of same made by A. E. Dalton, Engineer
in May 1924, said plat being of record in the R. M. C.
office for Greenville County in plat book "D" at page 233
and having the following metes and bounds and
courses and distances to wit: Beginning at a point
on the Laurens Road, corner of lot no. 2, and running
thence along the line of lot no. 2, S. 31° 27' W. 154.5 feet
to a point in line of lot no. 6; thence S. 58° 33' E. 27.8
feet; thence S. 47° 36' E. 24 feet; thence N. 35° 37' E. 159.4
feet to a point at the Laurens Road; thence
along said road N. 58° 33' W. 6.3 feet to the beginning
corner and being a part of the land conveyed to
Home Builders Company by Mallie J. Glenn by deed
