Being on the North side of East Stone Avenue, in Ward 12 of the City of Greenville, being known as lot No. 10 of plat of Feb-20th-1891, recorded in Vol. 55, page 544, lying between Main and Elizabeth Streets, and being more particularly described as follows: Beginning at a point on Stone Avenue, 109 feet from the N.W. corner of Elizabeth Street and Stone Avenue, and running thence N. 17 E. 206 1/2 feet to a point in line of lot No. 37; thence along line of said lot No. 73 N. 54 1/2 feet to common corner of lots 37, 38 and 9; thence S 17 W. 206 1/2 to Stone Avenue, 54 1/2 feet to the beginning corner.
