AND IT IS AGREED, by and between the said parties, that the mortgagor is to hold and enjoy the said Premises until default of payment shall be made.

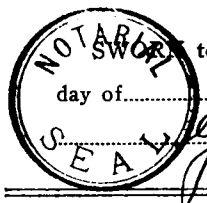
