edged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said PLANTERS SAVINGS BANK

All that certain piece, parcel and lot of land situate in the State and County aforesaid,
in Butler Township adjoining lands of J.A. Bull, W.W. Smith, Ed. Butler and others, being
a part of the tract of land formerly conveyed by Henry Stroud to M.A. Hendrix, and having
the following metes and bounds:

Beginning at stone 3x N. 24.40 E. 330 to stone; thence N. 25.20 W. 364.5 to stone; thence
N. 33 E. 1663 to stake 3x; thence down R. Creek 256 to bend; thence down said creek 1.83
to birch 3x on South side of said creek; thence S. 15 E. 402 to stake 3x; thence S. 42-30
W. 280.5 feet to S.W. gum stump 3x; thence S. 39.15 E. 508.2 to stake 3x; thence S. 33.15
E. 615 to stake in Pelham Road; thence up said road S. 37.30 W. 914 to angle; thence up
said road S. 56.15 W. 657 to stake center of new road; thence N. 61.30 W. 460 to stone 3x;
thence N. 42 W. 509 to beginning, containing 66 acres, more or less.
