All that certain lot of land situate, lying and being in State and County aforesaid in Oneal Township lying on the north side of Frohawk Creek. Beginning at a stone by an oak tree North of the road and running thence S. 72-5/8 E. 5.00 chains to a stake; thence S. 9-3/4 W. 17.00 chains to stake near a white oak at a fence; thence N. 73 W. 3.16 chains to a stake near near corner of a wire fence; thence S. 3-1/2 W. 8.62 chains to a stake by a wild cherry on the north bank of Frohawk Creek; thence up said creek S. 65 W. 8.50 chains to stake near a large stone on the North bank of said creek; thence N. 7-3/8 W. 14.24 chains to a stone original corner; thence N. 76 E. 2.03 chains to a stone (old corner) thence N. 34 E. 7.08 chains to beginning corner and contains 27.6 acres, more or less, bounded by lands of W.G.
