with interest from Date at the rate of eight per centum per annum until paid; interest to be computed and paid annually and if unpaid when due to bear interest at same rate as principal until paid, and I have further promised and agreed to pay ten per cent. of the whole amount due for attorney's fees, if said note be collected by an attorney or through legal proceedings of any kind, reference being hereunto had will more fully appear.

NOW, KNOW ALL MEN, That we the said Mary Blythe and A. A. Blythe in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof according to the terms of the said note and also in consideration of the further sum of Three Dollars to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said H. K. Jones, Attorney for Mrs. Arrie P. Jefferies all that piece, parcel, tract or lot of land situated in Greenville Township, Greenville County, State of South Carolina,

all that certain piece, parcel or lot of land, partly within and partly without the city limits of the city of Greenville, County and State aforesaid, near Sterling Industrial College, and having the following metes and bounds, to-wit: Beginning at a stake on a newly opened street extending from Dunbar to Jenkins Street, 100 feet from said Dunbar street, at the corner of lot owned by Lidia Griffin; thence with Dunbar Street S. 18 W. 115 feet to a stake 3 x n m on McPherson line thence along said line S. 76 3/4 E. 90 feet to a stake; thence N. 18 E. 115 feet to a stake, corner of lot owned by Lidia Griffin, thence N. 76 3/4 W. 90 feet to the beginning corner, and being the same land conveyed to us by George A. Arthur by deed dated March 3rd, 1920, to be recorded.
