in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

all that piece, parcel, tract or lot of land situated in Greenville

Township, Greenville County, State of South Carolina, situate, lying and being one mile west of the corporate

limits of the City of Greenville, known as Lot No. 37 on plat of Highland sub-division for J.M. Harris, recorded in plat book C., page 146, and having the following metes and bounds, to-wit: Beginning at a stake 70 feet south of Southeast corner of Gordon Street and Carolina Avenue, corner of Lot No. 38; thence with line of Lot No. 38, in an Easterly direction 130 feet to corners of lots 38, 44 and 45; thence with line of lot No. 44 in a southerly direction 70 feet to corner of Lots 36, 43 and 44; thence with line of lot 36 in a westerly direction 130 feet to stake on Carolina Avenue; thence with Carolina Avenue 70 feet to the beginning corner, and being the same lot conveyed to me by N.H.
