WHEREAS, I, John C. Davis

am well and truly indebted to Bank of Conestee, a corporation of South Carolina in the full and just sum of seven hundred seventy-nine & 77/100 Dollars, in and by my certain promissory note in writing, of even date herewith, due and payable on the 15th, day of Feb., 1921

at the rate of eight per centum per annum until paid; interest to be computed and paid semi-annually and if unpaid when due to bear interest at the rate of ten per centum per annum until paid. I have further promised and agreed to pay ten per cent. of the whole amount due for attorney's fees, if said note be collected by an attorney or through legal proceedings of any kind, reference being hereunto had will fully appear.

NOW, KNOW ALL MEN, That I, John C. Davis, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof according to the terms of the said note, and also in consideration of the further sum of three dollars to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Bank of Conestee

all that piece, parcel, tract or lot of land situated in Austin Township, Greenville County, State of South Carolina, containing 4.9 acres, more or less, conveyed to me by I.P. Kellatt by deed dated January 14, 1920, recorded in Book 66, page 306. Also that other tract in Township, County and State aforesaid, containing 50 acres, more or less, being conveyed to me by H.J. Haynsworth, by deed dated November 9, 1905, recorded in Book RRR, page 396; less however 13.8 acres conveyed by me to E.B. Hendrix, February 3, 1908, recorded in Book WWW, page 345. Also those two other tracts of land containing in the aggregate 126 acres, more or less, conveyed to Thomas J. Davis and myself, by Henry Moseley, by deed dated July 14th, 1903 recorded in Book JJJ, page 670; and by Thomas J. Davis to me by deed dated January 12, 1914 recorded in book 28, page 49, excepting however 46 acres conveyed by me to J.A. Tolbert January 4, 1916, deed recorded in Book 39, page 117. This mortgage is junior to one given by the said Thomas J. Davis and myself to A.K. Park by deed dated January 7, 1907, recorded in Book MMM, page 177.
