interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue  
thereon and foreclose this mortgage said note further providing for an attorney's fee of 10% of amount due hereon besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof if the same is placed in the hands of an attorney for collection, or if said debt, or any part thereof,  
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being  
thereunto had, as will more fully appear.

Beginning at a point on the west side of Pendleton Street, joint corners of lots 5 and 7, running thence with said Street, N. 72-58 26.10 feet 1 1/2 inches to a stake; thence along Easley Bridge Road (or Jones Road) S 59-27 26.53 feet; thence along line of lot 9 517 26.133 feet 10 1/2 inches; thence along line of lot 8 72-58 64 feet 6 inches; thence along line of lot 5 717 201 feet 9 inches to the beginning corner.
