be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being

bargain, sell and release unto the said E. M. Gillespie his heirs and assigns.

All that certain piece, parcel or plantation of land lying and being situate in State and County aforesaid in Bates Township and having the following metes and bounds to wit: Beginning at a maple corner on the North Saluda River running thence N 77 1/2 E. 11.50 to rock x n m, thence N. 34 E. 7.40 to pine dead x n m, thence S. 65 E. 8.32 to rock x n m thence N. 36 E. 10.30 to B.O. 3 n m; thence N. 34 26.17.15 to B. O. n m; thence S. 89 26. 6.00 to rock n m, thence 26.4.50 to Turkey Oak stump on Zinlay Bridge Road; thence S 87 1/2 26. 7.80 to bend in road thence N. 44 26. 8.00 to bend in road, thence N. 53 1/2 26. 2.85 to stump under bridge, thence the North Saluda river the line to maple the beginning corner and bounded by lands of J.
