interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue  
thereon and foreclose this mortgage, said note further providing for an attorney's fee of Ten per cent (10%)

besides all costs and expenses of collection, to be added to  
the amount due on said note to collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,  
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being

Street between Pendleton Street and Ferry Avenue

Beginning at a iron pipe Post on the west side of  
Leach Street one hundred and Fifty feet from the  
corner of Pendleton and Leach Streets and running  
thence north with Leach Street fifty feet (50 feet) to  
old Pickles' corner, thence west with line of Pickles  
lot and parallel with Pendleton Street one Hundred  
and ten feet (110 ft.) to Aiken's line, thence south
