WHEREAS, I, the said G. C. Gasikin

Dollars, to be paid In five equal annual payments

with interest thereon from annually at the rate of 7 per cent. per annum to be
computed and paid

until paid in full; all interest not paid when due bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue
thereon and foreclose this mortgage, said note further providing for an attorney's fee of 10%

besides all costs and expenses of collection, to be added to
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,
be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being
thereunto had, as will more fully appear.

bargain, sell and release unto the said Emmie Cason

all Rights Certain pieces, parcels, or lots of land
situate lying and being in Greenville Township,
Greenville County, State of South Carolina, being
Lot No. 36 of North Cherokee Park, according
to plat in Plat Book "C", Page 96, in R. M. C. Office
for Greenville County, said Lot fronts 60 feet on
East side of Keswice Avenue and running back
to a depth of 170 feet, more or less, to an alley, and is
fully described in deed to me by Cherokee Land
Company and F. C. Lupo, being same lot of land
conveyed to me by F. C. Lupo by deed dated August
31st, 1919, and recorded in R. M. C. Office for Greenville
County, in Vol. 64, Page 22.

Lot No. 37 of North Cherokee Park on the East
side of Keswice Avenue according to a plat recorded
