until paid in full. All interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue  
thereon and foreclose this mortgage, said note further providing for an attorney's fee of 10%

the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,  
be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being  
thereunto had, as will more fully appear.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said T. R. Bull

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said J. C. Harper  
in hand well and truly paid by the said T. R. Bull

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant,  
bargain, sell and release unto the said T. R. Bull his heirs and assigns

All that piece parcel or lot of land in Greenville Township,  
Greenville County, State of South Carolina in ward one of the city  
of Greenville on the south side of Stall Street and described  
as follows to-wit: Beginning at a pin on the south side of  
Stall Street, a distance of 259 feet from the south west corner  
of Rutherford and Stall Streets and running thence S 45 E. 118 feet  
more or less to a stake, thence N 87 1/4 W. 42 feet 4 inches  
to a stake, thence N 42 W. 118 feet ~~thence~~ more or less to
