at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said H. C. Graham, his heirs and assigns forever

All those two certain lots or parcels of land, situate, lying and being in the city of Greenville, in the county and state aforesaid, on the north side of Mills Avenue, designated as Lots 13 and 14 of Block D. of the Eagle Park Company property and having the following metes and bounds, to-wit:

Lat no 13: - Beginning at an iron pin on the north side of Mills Avenue, point corner of lot 13 and 14 and running thence with point line of said lot N. 1-33 W. 174 feet to iron pin, thence S. 89-07 W. 18.5 feet to iron pin, point corner of lot 13 and 12, thence with line of lots 13 and 12, S. 2-23 E. 163.4 feet to iron pin on Mills Avenue, thence with said Avenue S. 81-42 E. 67 feet to the beginning corner. This being the same lot of land conveyed to me by the Eagle Park Company, by deed dated June 2nd 1919 and recorded in the R.M.C. Office for Greenville County in Vol. 25, page 459.

Lat no 14: - Beginning at an iron pin on the north side of Mills Avenue, point corner of lot 13 and 14, and running thence with point line of said lot N. 1-33 W. 174 feet to iron pin, thence S. 89-07 E. 68 1/2 feet to iron pin, thence S. 0-23 E. 150.2 feet along point lines of lots 14 and 15 to an iron pin on Mills Avenue thence with Mills Avenue N. 76-58 W. 47 feet to the beginning corner, this being the same lot of land conveyed to me by the Eagle Park Company, by deed dated June 2nd 1919 and recorded in the R.M.C. Office for Greenville County in Vol. 25, Page 458
