I, Mrs Genie Allison of Greenville S.C. Pt #4, SEND GREETING:

WHEREAS, I, the said Mrs Genie Allison
in and by a certain promissory note in writing, of
even date with these presents, am well and truly indebted to

in the full and just sum of One thousand
Dollars, to be paid One year from date

with interest thereon from the day of Dec 1922
computed and paid at the rate of 15% per annum

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount of said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN That I the said Mrs Genie Allison
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mrs Kate Pruitt

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said Mrs Genie Allison
in hand well and truly paid by the said Mrs Kate Pruitt

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mrs Kate Pruitt, her heirs and as-

signs forever: A certain piece, parcel or tract of land lying in Austin Township County and State aforesaid, Bounded by lands of D. P. Cox L. F. Spillers, Misk Allison, E. F. Griffin and others, containing ninety (90) acres, more or less and being tract # 3, in plat of survey of lands of estate of Mary J Clark, made by W. J. Adams, Surveyor, on the 25th day of June 1911, and conveyed to me by J. W. Gray, Master, (said tract being Int. described in said deed) by deed dated Mar. 8th, 1911, and recorded in the office of R. M. C. for the County, in Vol. 3, at page 51. This conveyance does not cover thirty eight (38) acres, of the above described tract, that had been conveyed by me to E. F. Griffin, about four years ago.
