Dollars, to be paid Dec. 1, 1920.

with interest thereon from December 1, 1920 the rate of 6 per cent. per annum to be  
computed and paid Annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue  
thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent besides all costs and expenses of collection, to be added to  
the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof,  
be collected by an attorney, or by legal proceedings of any kind, all of which is secured under this mortgage, as in and by the said note, reference being

at an iron pin near crossing of said roads and  
running thence with Jordan road N. 45 1/2 W -  
9.33 to iron pin in said road. Thence South

17.87 to iron pin in new cut road, thence  
with said road about 29.70 chains to beginning
